1. Welcome – Kevin Arthur

Introductions were completed around the table.

2. Welcome new advisory committee members

Dean welcomed the new members and thanked them for their participation.

- 3. Bureau of EMS and Preparedness Updates
 - a. UDOH Emergency plans review –Dean Penovich Dean explained that Michelle is working on the COOP plan and Michelle will review at the next meeting.
 - b. UDOH Pandemic Influenza plan review/feedback Dean Dean read Keegan's email regarding this plan. Planning a meeting July 1st to incorporate comments into plan (will forward email to committee for review and input).
 - c. Public Health MYTEP/upcoming FSE-Lanette Sorensen
 Lanette explained that we are required by the grant to do trainings and exercises. June 2020
 will be the next full- scale exercise. The activities between now and then will lead up to the
 full-scale exercise. We have found success with WebEOC trainings. July 17th we will be
 doing a table-top exercise with ASTHO simulation the closure of pain clinics (this is opioid
 focused). Let her know if you would like to attend. People that attend this exercise can take
 this information back to others.
- 4. Crisis Standards of Care Kevin McCully

Contingency care – Adhoc decisions were made in Memorial Hospital during Katrina. Looking at what may be needed during an event. Expanding the scope: 1-Moral/ethical decision making, 2-Legal piece-operating outside their scope of care, 3- Clinical guidance-clinical findings, age factor, etc.

Normal care may not be possible when you have a large event. Continued use of Pandemic Standard of Care, only so many resources in an event. We are at the next step now which includes training to specialty hospitals which includes training and resources for them.

5. PHEP & HPP Cooperative Agreements – Kevin McCulley

Operate on 5-year projects normally, but joint project between ASPR and CDC wasn't working. New 5 year cooperative agreements now start 7/1/2019. The joint risk assessment shows the #1 concern and varies across the state by local region. Ongoing risk assessments and collaborations. Healthcare preparedness program for HPP, four parts, 1, Foundation for healthcare for medical readiness, 2. Healthcare Medical Response Coalition, 3. Continuity of Operations Planning, 4. Medical Surge events.

NDMS- Salt Lake VA Medical Center serves as the receiving hub. Special Surge Annexesstarting to look at this more specifically. Public Health Preparedness Program-Medical Preparedness and Public Health Preparedness are related but distinct projects.
