(1) US 6 (RP 24.8 - RP 27.5)

(a) Vehicles or loads exceeding 14' in width require two certified pilot/escort vehicles and two police escorts.

(2) US 6 at RP 231.75.

(a) Vehicles/loads exceeding 17'3" in height are prohibited.

(3) US 6 Eastbound at 239.3

(a) Vehicles/loads exceeding 20' in height are prohibited.

(4) State Route 9 is restricted between RP 32.6 to 44.7. See Zion's National Park Roadway Restrictions

(5) State Route 12 between the junctions of State Route 89 and State Route 24 (RP 0.0 - RP 122.8) (near Torrey, Utah).

- (a) Vehicles/loads exceeding 10' in width require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 12' in width require two certified pilot/escort vehicles.
 - (c) Vehicles/loads exceeding 14' in width require two police escorts, in addition to certified pilot/escort vehicles.
 - (d) Vehicles/loads exceeding 16' in width will require three police escorts.
 - (e) Vehicles/loads exceeding 13' in height are required to obtain access to bypass roadway at RP 4.6. Please contact UDOT Region 4 for access, 435-893-4799

(6) State Route 14 between State Route 130 (RP 0) and State Route 89 (RP 41).

(a) Vehicles/loads exceeding 14' in width require two certified pilot/escort vehicles and two police escorts.

(7) State Route 18 between the junctions of Interstate 15 to the junction of State Route 56 (RP 0 - RP 51).

(a) Vehicles/loads exceeding 16' in height require three police escorts for detour at RP 8.2 - 8.9 Northbound on/off ramp, using west roundabout bypass.

- (8) State Route 24 between State Route 12 (Torrey) (RP 72) and State Routes 24 & 95 (Hanksville) (RP 115).
- (a) Vehicles/loads exceeding 10' in width require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 12' in width require two certified pilot/escort vehicles.

(9) State Route 29 between Orangeville and Joe's Valley Reservoir.

(a) Vehicles/loads exceeding 12' in width and 75' in length require two certified pilot/escort vehicles and two police escorts.

(10) State Route 31 between RP 0 and RP 8.5.

- (a) Vehicles/loads exceeding 10' in width or 75' in length require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 12' in width require two certified pilot/escort vehicles and two police escorts.
- (c) Vehicles/loads exceeding 14' in width are prohibited.

(11) State Route 39 between State Route 203 (Harrison Blvd) at RP 9 and State Route 158 (Pineview Reservoir).

- (a) Vehicles/loads exceeding 10' in width or exceeding 77' in length are prohibited.
- (12) State Route 39 between State Route 158 (Pineview Reservoir) and State Route 16 (Woodruff at RP 67).
 - (a) Vehicles/loads exceeding 10' in width or 80' in length require two certified pilot/escort vehicles.

(13) State Route 43 and State Route 44 between Wyoming and State Route 191 (RP 0 - RP 28).

- (a) Vehicles/loads exceeding 95' in length require two certified pilot/escort vehicles.
- (b) Vehicles/loads exceeding 14' in width and/or 105' in length require two certified pilot/escorts and three police escorts.

(14) State Route 46 between the Colorado State Line and RP 18.

- (a) Vehicles/loads exceeding 10' in width or 80' in length require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 12' in width or 110' in length are prohibited.

(15) State Route 59 between RP 20 and RP 23 (Hurricane Hill).

- (a) Vehicles/loads exceeding 12' in width or 85' in length require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 14' in width or 95' in length require two certified pilot/escort vehicles and two police escorts.
- (c) Vehicles or loads exceeding 16'in width require two certified pilot/escort vehicles and three police escorts.

(16) State Route 65 between Interstate 80 and Interstate 84 (Henefer to Mt. Green).

(a) Vehicles/loads exceeding 80,000 pounds GVW are prohibited.

(17) State Route 66 between State 65 and Interstate 84.

(a) Vehicles/loads exceeding 80,000 points GVW are prohibited.

(18) State Route 76 at RP .34 between the Jct. of I-70 to the Jct. of SR-72.

(a) No Loads in excess of 34,000 lbs. tandem axle weight.

(19) State Route 89 (Logan Canyon) between RP 461 and RP 498 (Bear Lake).

- (a) Vehicles/loads exceeding 10' in width or 80' in length require one certified pilot/escort vehicle.
 - (b) Vehicles/loads exceeding 12' in width are prohibited.

(20) State Route 89 Arizona to Kanab. (RP 0.0 - RP 63.83)

(a) Vehicles/loads exceeding 16' in width and 75' in length require two certified pilot/escort vehicles and three police escorts.

(21) State Route 89A between Arizona (Fredonia) and Jct. US-89 Kanab. (RP 0 - RP 3)

(a) Vehicles/loads exceeding 16' in width and 75' in length require two certified pilot/escort vehicles and three police escorts.

(22) State Route 92 between Highway 189 (Provo Canyon) and the Sundance Ski Resort.

- (b) (a) All oversize loads require two pilot/escort vehicles and two police escort vehicles.
- (23) State Route 128 between Interstate 70 and State Route 191 (RP 0 RP 41).

(a) All oversize vehicles/loads exceeding 55,000 pounds GVW are prohibited.

(24) State Route 137 just south of the Jct. with Christianburg Rd.

(a) No loads in excess of 34,000lbs on a tandem axle group.

(25) State Route 143 between RP 3 and RP 20 (Parowan to Brian Head).

- (a) Vehicles/loads exceeding 10' width require one certified pilot/escort vehicle.
 - (b) Vehicles/loads exceeding 12' in width require two certified pilot/escort vehicles and two police escorts.
- (c) Vehicles/loads exceeding 14' in width and 75' in length are prohibited.

(26) State Route 148 from State Route 143 to State Route 14.

(a) Vehicles or loads exceeding 26,000 GVW prohibited through Cedar Breaks National Monument.

(27) State Route 150 between Utah/Wyoming Border and State Route 32 in Kamas, Utah.

(a) Vehicles/loads exceeding 80,000 pounds GVW are prohibited.

(28) State Route 153 between RP 9 and RP 20 (Elk Meadows to Beaver).

(a) Vehicles/loads exceeding 14' in width and 75' in length are prohibited.

(29) State Route 189 (Provo Canyon) between RP 7 (SR-52) and RP 21 (Wallsburg Jct).

- (a) Oversize loads in excess of 10' wide are prohibited.
- (b) Loads in excess of 10' width may be allowed on a case by case basis with a letter of authorization from UDOT Motor Carrier Division.

(30) State Route 190 (Big Cottonwood Canyon) between Interstate 215 at Knudsen's Corner and the Salt Lake/Wasatch County Line.

- (a) Vehicles/loads exceeding 9' in width or 65' in length require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 10' in width or 80' in length require two certified pilot/escort vehicles.

(c) Vehicles/loads exceeding 12' in width are prohibited unless a letter of authorization has been obtained from UDOT Motor Carrier Division.

(31) State Route 191 (Indian Canyon) between State Routes 6 and US 40. (RP 251.5 - RP 294.8)

(a) Vehicles or loads exceeding 14' in width or 105' in length require two certified pilot/escort vehicles and three police escorts.

(32) State Route 191 between Vernal, Utah and the Wyoming State Line (RP 355 - RP 404.2).

- (a) Vehicles/loads exceeding 95' in length require two certified pilot/escort vehicles.
- (b) Vehicles/loads exceeding 14' in width and/or 105' in length require two certified pilot escorts and three police escorts.
- (c) Vehicles or loads exceeding 20,000 pounds on single axles and/or 34,000 pounds on tandem axles are prohibited across Flaming Gorge Reservoir Dam.

(33) State Route 210 (Little Cottonwood Canyon) between State Route 190 and Alta, Utah.

- (a) Vehicles/loads exceeding 9' in width or 65' in length require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 10' in width or 80' in length require two certified pilot/escort vehicles.
- (c) Vehicles/loads exceeding 12' in width are prohibited unless written approval from UDOT Motor Carrier Division has been obtained.

(34) State Route 211 between State Route 191 and Canyonlands National Park (North of Monticello).

- (a) Vehicles/loads exceeding 10' in width or 80' in length require one certified pilot/escort vehicle.
- (b) Vehicles/loads exceeding 12' in width are prohibited unless written approval from UDOT Motor Carrier Division has been obtained.

(35) State Route 224 near Empire Pass/Deer Valley (RP 0) to Sandridge Road (RP 4.3)

- (a) RP 0 RP 1.2 Vehicles/loads exceeding 45' in length are prohibited.
- (b) RP 1.2 RP 4.3 Vehicles/loads exceeding 65' in length are prohibited.

- (36) State Route 257 between the junction of State Route 21 (RP 0) and the junction of US-50/6 (RP 69.2).
 - (a) Vehicles or loads exceeding 14' in width require two certified pilot/escorts and two police escorts.
- (37) State Route 261 (RP 7 RP 10) (Moki Dugway) (SR 163 SR 95).
 - (a) Oversize/Overweight vehicles or loads prohibited.
- (38) State Route 264 between State Route 31 and State Route 96 (Electric Lake to East Fairview).
 - (a) Vehicles/loads exceeding 12' in width or 110' in length are prohibited unless written approval from UDOT Motor Carrier Division has been obtained.
- (39) Emigration Canyon between the Wasatch Drive/Sunnyside Ave. junctions and State Route 65.
 - (a) Vehicles/loads exceeding 9' in width or 65' in length require one certified pilot/escort vehicle.
 - (b) Vehicles or loads exceeding 10' in width or 80' in length require two certified pilot/escort vehicles.
 - (c) Vehicles/loads exceeding 12' in width are prohibited unless written approval from UDOT Motor Carrier Division has been obtained.

(40) Exceptions.

- (a) The department may grant written authorization for vehicles engaged in public works projects with an origin or destination within the restricted portion of the highways listed.
- (b) The department may grant temporary waivers to highway prohibitions provided additional police and certified pilot/escort vehicles are required. Other safety measures such as road closures, utility vehicle escorts, time of day limitations, may be required before a wavier is granted.
