### **WELCOME AND INTRODUCTIONS**

The meeting was called to order at 10:00 a.m. Chairman Mike Larsen welcomed those in attendance at POST Council.

### APPROVAL OF POST COUNCIL MINUTES

The POST Council minutes of June 13, 2011, were reviewed and the following motion was made:

Motion: Robbie Robertson motioned to approve the minutes of June 13, 2011.

Second: Executive Director Tom Patterson seconded the motion.

Vote: The motion passed with all in favor.

#### SATELLITE AUDITS

Lt. Wade Breur reported on the Salt Lake Community College Academy and the Utah Department of Corrections Academy audit.

The Salt Lake Community College audit identified one class missed being drug tested, which is an exception. Director Attridge informed Lt. Breur there was a miscommunication with the drug testing company. There were no other exceptions with this audit.

The Utah Department of Corrections Academy audit identified a few minor exceptions with defensive tactics. Sgt. Poret will coordinate with the academy instructors to correct the identified exceptions. Lt. Breur has discussed the exceptions with Director Miller-Fox and she has assured him the deficiencies will be fixed.

### POST TECHNOLOGY UPDATE

Manager John Jacobs reported a new online reporting system has been used this year for the reporting of in-service training hours. Ninety percent of all agencies participated in reporting in-service training hours with the new system. This system has improved the accuracy and efficiency of the in-service training hour report.

POST is in the process of revising the on-line POST application. POST is currently in a proof of concept process with the development company. This company will provide a web portal where a person can go online and complete the application. The electronic application will automatically go into POST's records and will not have to be printed.

### REPORT ON K-9 BALLISTIC VEST ACCOUNT

Director Stephenson informed the Council a bill was passed last legislative session allowing DPS to create an account that could collect money for K-9 ballistic vest. There has been one golf tournament raising approximately three-thousand dollars and currently, with other donations, the account has accrued thirty-six hundred dollars. POST is in the process of writing administrative rule to establish protocol of dissemination

of these funds.

### **DISCIPLINARY ACTIONS:**

Director Stephenson presented the following cases to the POST Council and reported, in addition to the following disciplinary cases, four officer's relinquished their peace officer certification.

#### **BEAU BABKA**

Offence – Misuse of Public Money Category – A Recommended Discipline- 4 year suspension Status – Resigned 1/14/2011

Director Stephenson gave a brief synopsis on the Babka case.

Beau Babka addressed the Council and apologized for his actions. He asked for mercy from the Council and requested his suspension be eighteen months, retroactive from January.

Director Stephenson informed the Council, per state statute, POST could consider this violation a felony and would warrant a revocation. POST has mitigated the case to a four-year suspension due to the low monetary value of the misused public money. This will still afford Babka the opportunity to get back into law enforcement, but he will be required to complete the basic training academy.

Chief Burbank stated the Council needs to be careful with mitigating this case too much because of the leadership positions Babka has held.

Motion: Executive Director Tom Patterson motioned to accept the recommended 4 year

suspension of Beau Babka's peace officer certification (1/14/2011 - 1/14/2015).

Second: Colonel Daniel Fuhr seconded the motion.

Vote: The motion passed with 9 in favor and 3 against.

#### **MICHAEL LABATO**

Offence – Assault Category – B & C Recommended Discipline- Revocation Status – Resigned 6/21/2010

Motion: Chief Terry Keefe motioned to accept the recommendation for revocation of Michael

Labato's peace officer certification.

Second: Sheriff Lamont Smith seconded the motion.

Vote: The motion passed with all in favor.

#### IAN F. SALTER

Offence – Falsely Obtaining/Dispensing Prescription Medication Category – A Recommended Discipline- Revocation Status – Terminated 8/26/2010

Motion: Sterling Provost motioned to accept the recommendation for revocation of lan Salter's

peace officer certification.

Second: Robbie Robertson seconded the motion.

Vote: The motion passed with all in favor. Executive Director Patterson recused himself.

**ROBERT CHRIS TRANI** 

Offence – Possession/Use of a Controlled Substance

Category – A

Recommended Discipline- Revocation

Status - Resigned 3/1/2011

Motion: Sheriff James Tracy motioned to accept the recommendation for revocation of Robert

Trani's peace officer certification.

Second: Sterling Provost seconded the motion.

Vote: The motion <u>passed</u> with all in favor.

### **BLAINE PACE**

Offence – Lewdness Involving a Child Category – B Recommended Discipline- 3 year suspension Status – Resigned 6/15/2010

Motion: Robbie Robertson motioned to accept the recommended 3 year suspension of Blaine

Pace's peace officer certification (6/15/2010-6/15/2013).

Second: Chief Terry Keefe seconded the motion.

Vote: The motion passed with all in favor. Executive Director Patterson recused himself.

### **ENOS G. SLIVERS**

Offence – DUI Category – D Recommended Discipline- 1 year suspension Status – Resigned 9/5/2010

Executive Director Patterson asked if Slivers has been working with another agency after resigning from Salt Lake City PD. Director Stephenson replied, not that he was aware of.

Motion: Colonel Daniel Fuhr motioned to accept the recommended 1 year suspension of Enos

Slivers' peace officer certification (9/5/2010-9/5/2011).

Second: Sheriff Lamont Smith seconded the motion.

Vote: The motion <u>passed</u> with all in favor. <u>Chief Chris Burbank recused himself.</u>

### **MICHAEL R. JONES**

Offence – Disorderly Conduct Category – E Recommended Discipline- 6 month suspension Status – Admin Leave/Resigned 6/13/2011

Chief Keefe expressed a concern about the recommendation because of Jones position as a chief administrator. Therefore, Jones should be held to a higher standard. Director Stephenson replied Jones plead guilty to an infraction and POST felt like a 6 month suspension was fair and consistent.

Motion: Chief Chris Burbank motioned to reject the recommended 6 month suspension and

suspend Michael Jones' peace officer certification for 1 year (6/13/2011-6/13/2012).

Second: Sterling Provost seconded the motion.

Vote: The motion <u>passed</u> with 11 in favor and 1 against.

#### **CASEY PHELPS**

Offence – Electronic Communication Harassment Category – E Recommended Discipline- Letter of Caution Status – Still Employed

Motion: Sheriff Lamont Smith motioned to accept the recommended Letter of Caution for

Casey Phelps.

Second: Sterling Provost seconded the motion.

**Vote:** The motion passed with all in favor. Executive Director Patterson recused himself.

Chairman Larsen asked if there was any other business to be discussed. Director Stephenson stated he would like to inform the Council of a new Emergency Vehicle Operation (EVO) program POST is implementing. POST is taking EVO training around the State to assist outlying departments. The details of this new program are going to be available at the Utah Sheriff's Conference next week.
