



TRAFFIC EXPUNGEMENT

EXPUNGEMENT OF TRAFFIC OFFENSES

Senate Bill 201

This bill allows most traffic offenses to be expunged without limit. Provides that traffic offense are not included in determining if a person is eligible for expungement*.

Petitioner can only expunge traffic charges from court records; expungement will not affect driving record.

UCA 77-40-105(4)

"The bureau may not count infractions, traffic offenses, or minor regulatory offenses when determining expungement eligibility."

NAME REMOVAL FROM SEX OFFENDER REGISTRY

Offender Registry Review

The fee to apply is \$168.00 If eligible, the certificate fee is \$25.00

HB 13

This bill allows a person on the Sex Offender and Kidnap Offender Registry to petition the court for removal after five years for certain offenses:

- *Unlawful sexual conduct with a 16-17 year old
- *Unlawful sexual activity with a minor

HB 18

This bill provides a judicial process offender 76-5-301 regarding kidnapping or 76-5-301 unlawful detention may petition court for removal from registry

PARDONS

Must apply for Board of Pardon Expungement and pay \$50 application fee

- Provide pardon documentation with application
- DOES NOT count against limit of expungements
- All pardoned crimes will be expunged
- No longer maintain a record of pardons
