- A national program
- Generic crime definitions (uniformity)
- Compares data across political boundaries
- *Crime in the United States*, Crime Data Explorer
- *Crime in Utah* reports

Uniform Crime Reporting (UCR)

Summary Reporting

- Created in the 1930s with minimal changes
- Hierarchy rule
- Unable to capture as much data

National Incident Based Reporting System (NIBRS)

- Collects more detailed information
- No hierarchy rule
- FBI transition to only NIBRS UCR system January 1, 2021

Uniform Crime Reporting (UCR)

- Crime as it becomes known to law enforcement
 - Does not track what happens with the prosecutor or the court
- Index Crimes
 - Homicide, rape, assault, larceny/theft etc.
- Arrest data for adults and juveniles

Utah Senate Bill 105: Crime Statistics Reporting Amendments

- Prior to this bill:
 - Participation in the state UCR program was voluntary
 - Problems with consistency in data received
 - Timeliness
- Objectives of bill:
 - Statewide participation
 - More accurate, reliable data
 - Better information for law enforcement agencies, administrators, public officials, and the general public

Utah S.B. 105

- All law enforcement agencies required to participate
- Monthly submissions
- Validation requirement
- Utah transition to NIBRS

29 *Be it enacted by the Legislature of the state of Utah:*

30 Section 1. Section 53-10-205 is amended to read:

31 **53-10-205. Uniform crime reporting system -- Reporting timelines and use of**
32 **data.**

33 (1) The data acquired under the statewide uniform crime reporting system shall be used
34 only for research or statistical purposes and may not contain any information that may reveal
35 the identity of an individual victim of a crime or law enforcement officer.

36 (2) A law enforcement agency shall, for the jurisdiction of the law enforcement agency,
37 submit crime reporting data required for the statewide uniform crime reporting system
38 described in Section [53-10-202](#):

39 (a) to the bureau before the 16th day of the month after the month in which a reported
40 crime occurs; and

41 (b) in a manner prescribed by the bureau and in compliance with the requirements of
42 the Federal Bureau of Investigation's uniform crime reporting standards.

43 (3) Upon request of the bureau, a law enforcement agency shall review and verify
44 crime reporting data within 10 business days after the day on which the law enforcement
45 agency receives the request.

Uniform Crime Reporting



The Uniform Crime Reporting (UCR) Program has been the starting place for law enforcement executives, students of criminal justice, researchers, members of the media, and the public at large seeking information on crime in the nation. The program was conceived in 1929 by the International Association of Chiefs of Police to meet the need for reliable uniform crime statistics for the nation. In 1930, the FBI was tasked with collecting, publishing, and archiving those statistics.

Today, four annual publications, *Crime in the United States*, *National Incident-Based Reporting System*, *Law Enforcement Officers Killed and Assaulted*, and *Hate Crime Statistics* are produced from data received from over 18,000 city, university/college, county, state, tribal, and federal law enforcement agencies voluntarily participating in the program. The crime data are submitted either through a state UCR Program or directly to the FBI's UCR Program.

In addition to these reports, information is available on the Law Enforcement Officers Killed and Assaulted (LEOKA) Program and the Hate Crime Statistics Program, as well as the traditional Summary Reporting System (SRS) and the National Incident-Based Reporting System (NIBRS).

Note: In response to user feedback regarding the streamlining of *Crime in the United States, 2016*, the FBI has published an amendment containing 70 supplemental tables to the report.

The FBI is undertaking a redesign of the system that has supported the FBI's UCR Program for more than 30 years. In support of this initiative, the FBI is currently managing the UCR Technical Refresh. [Details](#)

 - By location, time period, and type of crime
- View charts and graphs that break down data in various ways
- Select data to display in either Summary or NIBRS
- Download selected reports, NIBRS data, and other bulk datasets
