Dear Kelly James,

This letter is in response to your GRAMA request dated April 7, 2017. I'm sending the information we have in the Division of Finance. The Division of Finance includes the "Office of Utah's Transparency". There is no separate Office of Transparency, but financial transparency and the website is one of our functions.

Here is a response to the specific items in your request.

1. You requested the salaries of the highest officer for five specific Utah special districts and you mentioned that information was not available for review and download from the transparency website.

Response: Unfortunately, we are dependent on the special districts and other participating entities for the information they upload. So, we do not have possession of that information. You would need to request the information from the specific special district.

2. You requested a copy of the letter from John Reidhead to Gunnison Valley Hospital regarding the applicability of GRAMA. This letter was sent prior to the January 8, 2013 Transparency Advisory Board Meeting.

Response: A copy of the letter is attached.

3. You requested the total number of "special districts" in Utah.

Response: Ryan Roberts from the Office of the Utah State Auditor will be responding to this part of your request.

4. You requested "the names of all special service districts required to submit data to the Utah transparency website but did not submit that required data from 2010 to present".

Response: Our transparency specialist prepared the attached Excel spreadsheet. The spreadsheet is to show those special service districts that are missing information since 2010.

Regarding the spreadsheet, please note the following:

- A. If a cell on the spreadsheet is blank, that means the SSD complied and submitted their information. If there is an entry in a cell, that indicates data that has not been submitted.
- B. Only special service districts with annual revenues or expenditures greater than \$1,000,000 were required to submit information to the website as of May 2011 (for 2010 information) up until January 1, 2017. Those under \$1,000,000 do not have to start to comply until January 1, 2017, and those under \$100,000 do not have to comply until July 1, 2017. The first due date for SSD's under \$1,000,000 to submit information is April 30, 2017. And the first due date for SSD's under \$100,000 is October 31, 2017. Because these initial due dates have not passed, we have excluded these smaller SSD's from the spreadsheet. However, some of these entities have already submitted information.
- C. The list only includes special service districts created under *Utah Code* Title 17D Chapter 1. We track the special service districts separately from local districts and public transit districts based on the transparency statutes in *Utah Code* Title 63A-3-405.

You have the right to appeal any decision we've made in responding to your request by filing a notice of appeal within 30 days to:

A notice of appeal must contain the following: petitioners name; mailing address; daytime telephone number; and relief sought. The notice of appeal may also include a short statement of facts, reasons, and legal authority in support of the appeal.

RE: Reporting Financial and Employee Compensation Data to State's transparency website.

Dear Mr. Dalley:

The Utah Transparency Advisory Board (Board) has been considering the Gunnison Valley Hospital's (Hospital) request to be exempted from the statutory requirements to report financial and employee compensation data (data) on the State's transparency website. The transparency reporting statutory deadline for Special and Local Service Districts was May15, 2011. See Utah Code 63A-3-405(2)(a).

The Board has considered in some of its previous meetings the Hospital's underlying arguments to their exemption request. However, at its last meeting on September 20, 2012, the Board approved a motion for the Division of Finance to notify the Hospital that the threshold for complying with the State's transparency statute is whether the Hospital is exempt from providing this type of data under the State's Governmental Records and Management Act (GRAMA). See Utah Code 63G-2.

The Board members, including Senator Wayne Neiderhauser - Board Chair, agreed that if the Hospital is subject to GRAMA, and must comply with a GRAMA request for this type of data, then the Hospital should comply with the transparency statute and submit information to the State's transparency website.

If the Hospital can provide the Board with specific citations from GRAMA that would clearly exempt the Hospital from complying with a GRAMA request for this type of data, then the Board would likely exempt the Hospital from the requirement to submit this type of information to the State's transparency website.

If the Hospital is subject to GRAMA and still does not believe they should be required to submit data to the State's transparency website, then the Board recommended that the Hospital pursue legislation to exempt the Hospital from the State's transparency statute.



The Board will be meeting again on January 8, 2013, at 8:00 a.m. in room 415 of the State Capitol and may make a final decision on this matter. Therefore, the Board invites Hospital representatives to attend the January meeting to provide any additional input or information related to your request for an exemption.
