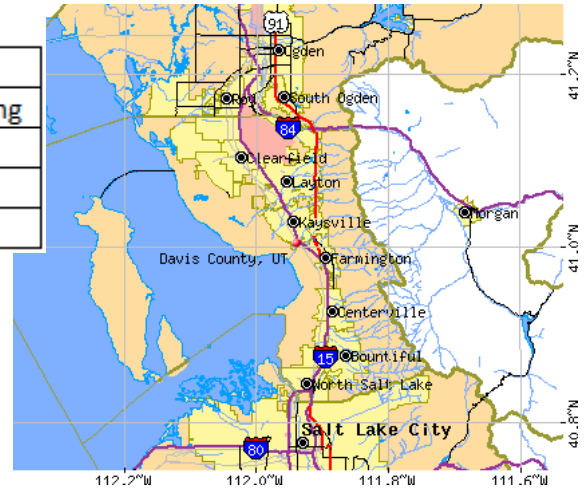




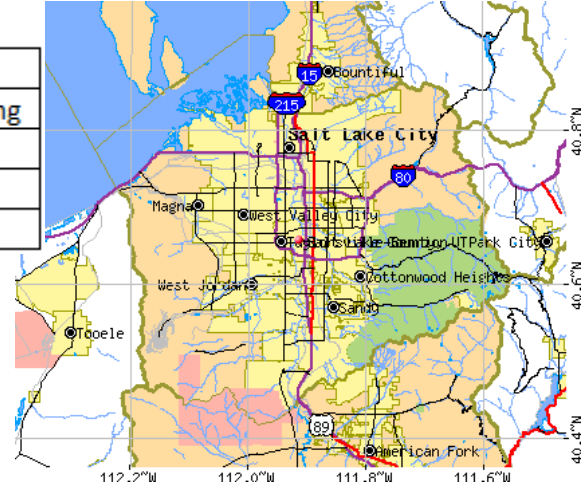

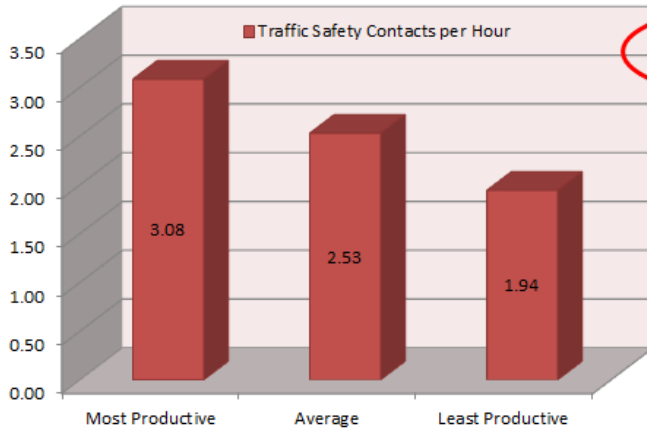

Just wanted to give you a few details about our HOV Blitz in Feb/March. We had to cancel all the shifts for Monday the 27th because it was snowing. We had three troopers that stood out and I wanted to highlight their enforcement efforts.
